A letter from Pastor Dana...

Friends in Christ,

At the end of April, I attended the Ecumenical Round for Faith and Science. I have been attending this event for eight years and I just happened to be the one in charge this year! The theme was, "Hope amidst the Climate Crisis," and we had about 31 people, 15 in-person and 16 virtually from the ELCA and PCUSA (Presbyterian).

I left feeling challenged to start giving an ecological tithe. My biggest take away was the very real need to simplify accessibility. For example, clean energy is not very accessible. So, how can the Church move the needle on this issue? I'd love to say we came up with great answers, but I couldn't deny a big shift in our conversation from clean energy to AI.

While we had motivating speakers and discussion around clean energy (e.g., solar, wind turbines, electric cars), it was clear that there is a timely urgency around issues of science and faith to technology and ethics. Consider ChatGPT. If you're unaware, please google it. While ChatGPT gets the limelight right now, other artificial intelligence (AI) advances are developing fast. You encounter it on a daily basis and likely don't even realize it. Alexa, turn off the lights!

In 2020, the church world was thrust into technology like never before. I'd say most congregations will always stream worship from here forward (until something new comes along...). In sharing our fears around ethics and AI, I was also happy to share with the group two God given gifts. I will admit though that there are more than two! I could and will worship with you during my recoveries, and others in this congregation can share that same story!


Here's what I shared with the group at the conference:

- 1. We had an assisting minister use ChatGPT to write the Sunday morning prayers. And it really did a good job. I did point out it may have written them, but it could not proclaim them.
- 2. We have a woman who has been worshipping with us from British Columbia (where there are not many worshiping communities) who will be moving here soon. She already feels a part of the congregation. She has joined theological discussions on Thursday via Zoom and has said, "I already feel like I know the church and you."

I don't know what struggles we will run into, but I do know that we can pray that God will use technology for love and spreading the gospel. I mean if it wasn't for the printing press, Luther would not have spread a German translation of the Bible so quickly into the hands of everyday people. I pray we embrace technology cautiously and find the ways it will help evolve the Church into what God is calling us to be.

2023 Synod Assembly

From May 7-9, Pastor Dana, Ted Tuma and Saran Gilbert attended our synod's annual meeting, held here in Mt. Pleasant. Also representing Immanuel was Linda Wicander who is a member of the synod's executive committee.

The three days of meetings included worship, song, reports from synod committees, discussion, and voting. Bishop Satterlee also proclaimed the theme of the assembly as "It's all about Jesus"; and the theme was repeated in seminars and messages. The in-person assembly allowed people from across the Lower Peninsula to reconnect after not meeting in person for several years. Also, significant anniversaries of ordination were celebrated, including our own Pastor Dana being recognized for 15 years of ordination.

Critical items on the three-day agenda were budgets, proposed compensation for pastors, and next year's synod assembly. Budgets and reports for various committees were presented and approved, and proposed compensation was given to individual churches to take back to their congregational councils. The topic that generated the most discussion before coming to a vote was how to hold the 2024 synod assembly – whether in-person or virtually. When the question was called, the vote showed that next year's assembly would be virtual, primarily due to the projected costs.

The three days were productive for all of us representing Immanuel – and it showed us several things. First, how fortunate we are to be part of an energetic and alive congregation; second, how God continues to bless our congregation with significant resources, and third, how Immanuel continues to hear the Bishop's edict of "It's all about Jesus".
